GOLD & ABOVE OVERVIEW



- The qualification period for YL Escape is between 1st February to 31st July, 2020
- Achieve all three personalised targets to qualify for the Darwin Experience and the Vietnam Resort incentive.
- All members must hit the minimum rank of Executive at least once during the qualification period in order to qualify for the YL Escape (Tier 1 & 2).
- Personalised Targets will be issued to all registered Gold and above members for:

Category 2: Personalised Team Growth Target

THE DETAILS



Gold and above members will receive personalised targets to grow their specific business. Those wishing to participate in YL Escape must register via their Virtual Office.

QUALIFY FOR THE DARWIN FARM TRIP PLUS THE ESCAPE RESORT*

CATEGORY 1:

PERSONALLY ENROL NEW MEMBERS

Registered Gold and above members will receive personalised enrolment* targets set by the Young Living corporate team.

*Qualifying enrolment orders can be Standard or Essential Rewards orders, however, must satisfy the minimum 100 PV criteria.

CATEGORY 2:

RANK ADVANCE TEAM MEMBERS

Registered Gold and above members will receive personalised rank advancement** targets set by the Young Living corporate team.

**Only first-time qualifiers can contribute points. Requalifying Members will not earn points.

New qualifiers at the necessary rank can be at any level within your business but MUST be outside any downline Gold legs.

CATEGORY 3:

INCREASE YOUR OGV BASELINE BETWEEN FEBRUARY TO JULY 2020

Registered Gold and above members will receive personalised OGV*** targets set by the Young Living corporate team.

***Resort component only applies after personalised targets has been achieved on top of the baseline. The personalised target will be set by Corporate, considering qualifying OGV. Golds and above can only qualify for Tier 2. OGV baseline and Increase does may not include any downline team Gold's volume.







HOW DO I CALCULATE MY BASELINE OGV FOR CATEGORY 3?

Calculate your total OGV from July to Dec 2019 by adding them together & subtracting any existing gold leg OGV (i.e. = 100,000 OGV)

HOW DO I CALCULATE MY OGV INCREASE?

TIER 2:

Calculate your personal cumulative OGV growth from Feb-July 2020 by adding them together & subtracting any existing gold leg OGV (i.e. = 115,000 OGV)

ADDITIONAL INFORMATION:

Gold+ members must attain the minimum criteria of their personalised target, set by Young Living Corporate, to qualify for YL Escape.

NOTE:

- Maintain: A minimum 100 PV ER minimum order between February 2020 to July 2020, inclusive.
- All Members who register to participate in the YL Escape are required to keep a record of their progress using the Young Living Escape Accountability Tracker: http://bit.ly/YLEscapeTracker
- All Accountability Trackers must be submitted to the Young Living Corporate Office within 10 days of qualifying or by the nominated closing date of Monday, August 10, 2020.

- OGV baseline and Increase does may not include any downline team Gold's volume. Only Volume outside of this will contribute towards the qualification criteria.
