

QUALIFICATION, CRITERIA & ELIGIBILITY

- This promotion is open to active members of Young Living, who are 18 years of age or older, who have registered for the promotion and have their primary business and residential address listed as Australia or New Zealand during the promotional period.
- This promotion is open to all Young Living AUNZ members ranked Distributor to Royal Crown Diamond.
- · A Young Living Escape prize can only be won once by any participating Membership; Spouse Accounts are ineligible to qualify.
- All members must hit the minimum rank of Executive at least once during the qualification period in order to qualify for the YL Escape (Tier 1 & 2).
- International OGV will be counted towards your baseline OGV. In order to strengthen our business within the Australian and New Zealand markets, we encourage all members to continue to grow OGV domestically, however, we acknowledge that YL has no boundaries and recognise the advantages of growing internationally. Therefore, international OGV will be factored into baseline growth, however this will be capped at 40% of the total for both the accumulated OGV and growth target over and above your baseline. Please note that both Enrolments (Cat.1), and Ranks ups (Cat.2), must occur within either the Australian or New Zealand markets, and/or be local residents thereof.

GENERAL PRIZE CONDITIONS

- Tier 1 Qualifiers will receive a single, economy class return airfare from their nearest capital city to Darwin, NT.
