



Frequently Asked Questions

Q. Who can participate in the OilStars 2025 incentive program?

A. All Philippine-based Brand Partners can participate in this challenge.

Q. If I enrolled a new Brand Partner outside of the Philippines, will it qualify as an enrollment?

A. No, only Philippine-based enrollments will qualify.

Q. Do reactivations count as enrollments for this incentive?

A. No, reactivations will not qualify as an enrollment for this incentive.

Q. Can all 10 of my new enrollments be enrolled in the same month?

A. No. As a requirement, you must have 5 personal enrollments with 100 PV one-time purchase for August and another 5 for September. If you fell short of the requirements, you have the whole month of October to fulfill them. Having zero enrollment in August or September will mean disqualification.

Q. What if someone I personally enrolled re-ranked to Star during the promotion period, will it count as a New Star?

A. No. Only first-time achievers of Star or Senior Star rank will be qualified as a New Star or New Senior Star.

Q. If I didn't have a rank-up in August, but completed all 8 rank-ups in September and October, will I still qualify?

A. No. Having a zero rank-up in August or September will mean disqualification.

Q. If my personally enrolled member was in December 2024 and achieved the Star rank in August, will it qualify as a New Star?

A. No. For this incentive program, all personal enrollees who will rank up to Star or Sr. Star must come from 2025.

Q. If my personally enrolled member achieved Star in August and ranked up to Sr. Star in September, will it qualify as a New Sr. Star?

A. Yes. This means that you have completed the Leadership requirement for September.

Q. Can I do online classes?

A. Yes. Please ensure that you take a screenshot of your class. At the end of each month, a JotForm link will be provided for you to log the classes you conducted.

Q. Can I conduct all 4 classes in the same month?

A. No. As a requirement, you must conduct 2 classes each for August and September, or make up for the missing classes in October.

Q. Will we have a leaderboard for this incentive?
