### APAC TRAVEL INCENTIVE

#### Incentive Pre-Qualification

Young Living Dare (YLD) pre-qualification requirements for all YLPH Brand Partners interested to join the YLD Travel Incentive:

1. Be a PAID Executive or higher at least once either in November or December 2025.
2. Personally enroll TWO (2) new YLPH members with a minimum 100 PV enrollment purchase in a month, either in November or December 2025.
3. Complete the Intent to Join Form at <https://bit.ly/YLD-ITJ> by December 31, 2025.

#### Frequently Asked Questions

**1. Who are eligible to join the Young Living Dare (YLD) Travel Incentive?**

All YLPH Brand Partners who will complete the pre-qualification requirements, stated above, between November 1 and December 31, 2025 can join the YLD.

**2. Is meeting the pre-qualification requirements mandatory to participate in the YLD Travel Incentive?**

Yes. All participants must meet the pre-qualification requirements to be eligible for the YLD Travel Incentive. No exceptions will be considered.

*Please note: Meeting the pre-qualification requirements does not guarantee achievement of prizes in the YLD.*

**3. Will a Brand Partner be eligible to qualify for YLD if there's only one (1) enrollment in November and one (1) in December?**

No. The Brand Partner must enroll at least two (2) new YLPH members with a 100 PV enrollment purchase within the same calendar month, either in November or December 2025.

**4. Will a reactivation be counted as a new enrollee?**

For the YLD pre-qualification period, only NEW YLPH MEMBERS will be credited to the enroller-qualifier.

**5. What if a Brand Partner missed any one of the pre-qualification requirements between November and December? Can they still catch up once the YLD qualification period starts?**

No. Eligibility is based on the YLD pre-qualification requirements stated in FAQ #1.

**6. When will the YLD qualification period start?**

It will commence in January 2026.

**7. For new YLPH members who will join in December, will they be eligible to join the YLD without meeting the pre-qualification requirements?**

All new YLPH members in 2025 must meet the pre-qualification requirements by December 31, 2025:

- Be a PAID Executive or higher
- Personally enroll TWO (2) new YLPH members with a minimum 100 PV enrollment in a month
- Register through the Intent to Join Form at <https://bit.ly/YLD-ITJ>

**8. What enrollment kit can a new enrollee purchase for the enroller to meet the YLD pre-qualification requirement?**

An enrollee may purchase any available enrollment kit with at least 100 PV, such as the Premium Experience Set. They can choose to build their own enrollment kit with the Customized Enrollment Order.

**9. What if I enroll a new member from another Young Living market? Will this be credited toward the pre-qualification requirement?**

No. Only YLPH new members will be counted.

**10. How will a Brand Partner know if they have met the pre-qualification requirements and is eligible to qualify for the YLD?**

A list of eligible qualifiers will be shared with the field by January 2026.

**11. For new members who will join in January 2026, since they missed the pre-qualification period, are they still eligible to join the incentive?**

No. Only those who met the pre-qualification requirements between November and December 2025 will be eligible to qualify for YLD in January 2026.
