## **RULES**

### **Promotion Description**

The **Follow Your Dream – Live Your Passion Grand Convention Contest 2016** (the “Promotion”) is sponsored by Young Living Singapore Pte Ltd (“Young Living”). The contest period begins February 1, 2016, at 12 a.m., SG and ends at 11:59 p.m., SG, on April 30, 2016 (the “Promotion Period”). Young Living’s method of timekeeping is the official time clock for the Contest and is final and undisputable. Winners will be selected after the Promotion Period, based on the Members who earn the highest number of eligible point totals acquired through the Promotion Period. There will be 10 winners.

### **Eligibility**

#### *Personal Eligibility*

- This promotion is open only to distributors who have their primary billing (mailing) address as Singapore.
- Qualifying participants may only earn points when they personally enroll distributors within Singapore.
- Only distributors in active status (those who have made a purchase of at least 50 PV in the last 12 months) and who are over the age of 21 are eligible to earn points.

#### *Essential Rewards Eligibility*

In reference to earning points from Essential Rewards and Reactivations, you may only earn points from your personally enrolled members who place and maintain their qualifying Essential Rewards orders from Singapore (shipping address is Singapore).

### **How to Earn Points and Win**

Promotion participants may earn points from February 1, 2016 through April 30, 2016. A leaderboard of the top 50 point earners will be available in Virtual Office. Points will be accumulated based upon enrollments, reactivations, and enrolled members of your team participating in the Essential Rewards program during the promotion period.

## FAQ

### **Q: What are the dates for the promotion?**

A: February 1st, 2016 – April 30th, 2016

### **Q: Can anyone participate?**

A: You must be an active wholesale distributor, must be 21 years of age, and have your primary billing (mailing) address as Singapore.

### **Q: How can I check my points, status and ranking in the promotion?**

A: In your Virtual Office there will be a leaderboard with this information.

### **Q: How often do individual and leaderboard points update?**

A: Points update once a day, at approximately 6 a.m. MT.

### **Q: I have enrolled someone with a Starter Kit, but the points are not showing up on my individual point's board. What should I do?**

A: Confirm that the new enrollee has accepted the distributor agreement. Points will not be allotted until the enrollee has accepted his or her distributor agreement.

### **Q: What is meant by “Reactivate Personally Enrolled members”?**

A: Reactivate a member that had previously enrolled in your downline but didn't make the minimum purchases necessary to maintain their account in good standing i.e. 50 PV in a years' time. To earn the reactivation point that member would have to reactivate with a minimum purchase of 100 PV.

### **Q: How will I know if one of my personally enrolled members is deemed “inactive”?**

A: If your personally enrolled member no longer appears in your Downline Viewer, that member is already deemed “inactive”.

### **Q: How will I know if I've won a prize?**

A: All prize winners will be contacted by Young Living to officially recognize your win and explain how to claim your prize.

### **Q: Will Young Living book my travel or can I opt to do my own travel booking?**

A: Young Living will not book your travel and instead will provide credit for travel to Salt Lake City, Utah. Young Living will reimburse you up to \$2,000 Singapore Dollars. The reimbursable amount will be based on the allocated budget per winner, or the actual price of your travel, whichever is lower. You may use the travel credit for airfare and/or accommodation.

**Q: Will Young Living cover my hotel accommodation in Salt Lake City, Utah?**
