TERMS AND CONDITIONS

Programme Details

Scentsability Programme (“Programme”) is organised by Young Living Singapore Pte Ltd. located at 111 Somerset Road #05-18 111 Somerset, Singapore 238165 (“Young Living” or “Young Living Singapore”). The Programme is intended to be a duplicable community growth strategy that develops leaders, strengthens retention, and builds a sustainable wellness business. It does not replace other qualifications or compensation under the Young Living Compensation Plan.

Qualification Period

The Programme begins on May 1, 2026, at 12:01 a.m. Singapore Standard Time (SST) and ends on May 31, 2026, at 11:59 p.m. SST (“Qualification Period”). Young Living’s method of timekeeping is the official time clock for the Programme and is final and undisputable.

Eligibility

The Programme is open to active eligible Young Living Singapore Brand Partners (also referred to herein as “Host”) who are in good standing with Young Living; are 18 years of age or older as of May 1, 2026; and meet the following TWO (2) criteria:

1. Have a primary billing address listed on their Brand Partner Account as Singapore.
2. Must be an active Brand Partner: Active is defined as having made a purchase of at least 50PV in the last 12 months and are in compliance with all of the terms of their Young Living Brand Partner Agreement and meet the active requirements outlined in the Young Living Policies and Procedures.

How to Participate

1. To participate in this Programme, Brand Partners must fill in the Opt-in form, available at https://bit.ly/YLSG_TWCmay26_optin. The Opt-in form will be available from April 1, 2026,

at 12:01 a.m. SST to April 10, 2026, at 11:59 p.m. SST. Young Living will not accept any late submissions. Brand Partners will be informed of their eligibility via email on April 13, 2026 after the opt-in period.

2. The Host is required to attend the Host briefing for the Programme on April 16, 2026.
3. The Host is required to purchase at least one (1) Host Party Kit and one (1) Host Business Tool Kit.
4. The Host is required to host at least TWO (2) in-person events with a minimum of four (4) guests each within the Qualification Period. The Host must share the events on social media using #YLSG and #YLScentsability.
5. The Host must enroll at least TWO (2) new or reactivated Brand Partners in Young Living Singapore, with any bundle from the Scentsability Signature Scent Collection featured in this Programme.

Host Party Kit and Host Business Tool Kit Terms and Conditions

1. The Host Party Kit and Host Business Tool Kit are only available for purchase by “The Host” of the Programme, on a while stocks last basis.
2. The Host Party Kit includes the following and is intended for your event attendees’ usage during your events:

6. For processing of the Host Party Kit and Host Business Tool Kit, the Host must have a working credit card on file for payment. Once payment is successful, the qualifying Host will receive an email confirmation with collection details and/or stock updates.
7. For any unsuccessful payment, qualifying Host will also be notified via email.
8. Young Living Singapore reserves the right to cancel, modify or supersede the terms of this Programme at any time.

4. Young Living Singapore reserves the right to substitute items in the Host Rewards should there be unforeseen circumstances where items run out of stock.
5. Young Living Singapore reserves the right to cancel, modify or supersede the terms of this Programme at any time.
6. Young Living Singapore's decision on the qualifiers is final.

General Rewards Terms and Conditions

1. By participating in the Programme, each Host agrees to abide and be bound by these terms and conditions (the "Rules").
2. Host further agrees to abide by and be bound by all decisions of Young Living which shall be final and binding, without right of appeal, in all matters relating to the Programme and reward(s), including without limitation, eligibility and/or disqualification of entries.
3. Any back order or product return within the qualification period will not count towards the eligibility of the promotion.
4. Upon verification of qualification and not later than the third week of the following month, Young Living will notify eligible Host via the email address registered to their Brand Partner account. Notification is deemed received when sent.
5. In the event of a cancelled event or a qualifying enrollment order is cancelled or returned within ninety (90) days from the date of such order after the Reward is issued, Young Living reserves the right to recover from the Host the fair market value of the Reward (including by offset against commissions or other payments payable to the Host).
6. Reward(s) are not transferrable or redeemable for cash, except that Young Living reserves the right, at Young Living's sole discretion, to substitute a Reward (or portion thereof) for a Reward of equivalent value.
7. Reward(s) are "AS IS" and WITHOUT WARRANTY OF ANY KIND, expressed or implied, including, without limitation, any implied warranty of merchantability or fitness for a particular purpose.

8. Cancellation and Refunds; Force Majeure. If a qualifying order is cancelled or returned in accordance with Young Living's applicable return policy, the Host will forfeit eligibility for the Reward. Nothing in this clause restricts or excludes any statutory rights under applicable Singapore law. Young Living will not be held responsible if fulfillment of the Reward is prevented or delayed due to any of the following: strikes including transportation or workers' strikes, picket lines, boycott efforts, fires, floods, accidents, war (whether or not declared), revolution, riots, insurrections, acts of God, acts of government (including, without limitation, any agency or department of the government or local authorities in the markets on this promotion), acts of the public enemy, scarcity or rationing of gasoline or other fuel or vital products, inability to obtain materials or labor, epidemic or pandemic, or other causes that are reasonably beyond the control of Young Living.

9. License and Privacy. Young Living and its authorized agents will collect, use, and disclose the personal information you provide when you participate in the Program for the purposes of administering the award fulfillment. All personal data will be collected, used, disclosed, and processed in accordance with the Young Living Privacy Policy and the Personal Data Protection Act 2012 of Singapore. Hosts may withdraw consent in accordance with applicable law, subject to any legal or contractual restrictions. By participating in the Programme, Host consents to the use of their name, address, voice, statements relating to the Programme and Young Living, and photographs or other likeness, without further compensation, notification, or permission, in any publicity or advertising carried out by Young Living or any related entities in any media without territorial or time limitation, except where prohibited by law.

10. Limitations of Liability. Young Living and its affiliates, subsidiaries, and parent companies are not responsible for any inaccuracies in information that may be used in the Programme, for any technical or human error that may occur in the processing of orders, including data entered by Host, any miscommunications such as technical failures related to computer, telephone, cable, and unavailable network or server connections, related technical failures, or other failures related to hardware, software, or virus, or incomplete, late, or misdirected orders. Any compromise to the fair and proper conduct of the Programme related to a computer virus or similar type of technical impairment that may affect the proper fairness, security, and administration of the Programme may result in the termination, amendment, or modification of the entire Programme or a portion thereof at the sole discretion of Young Living. Young Living reserves the right, in its sole discretion, to void any order of any Host whom Young Living believes have attempted to tamper with or impair the administration, security, or fairness of the Programme or to disqualify any Host who acts in a non-sportsmanlike manner or with the intent to threaten or harass any other person. By participating in the Programme each Brand Partner waives all rights to claim punitive, incidental and consequential damages, attorneys' fees, or any damages other than actual out-of-pocket costs or losses that may arise in connection with participation in the Programme, acceptance, possession, and/or use of the Reward. All causes of action arising out of or in connection with the Programme or the Reward awarded shall be resolved individually, without resorting to any form of

class action. Some jurisdictions may not allow certain limitations on damages or the ability to seek damages through a class action, so some of these restrictions may not apply to you. Nothing in these Terms and Conditions excludes or limits liability for death or personal injury caused by negligence, fraud, or any other liability which cannot be excluded or limited under applicable Singapore law.

11. Other Rules and Regulations. Each Reward recipient will be responsible for all applicable taxes on their Reward, whether or not the Reward is used, unless they refuse to accept the Reward at the time it is presented. Where applicable, the Reward recipient will have the fair market value of the accepted Reward reported on an applicable tax form. Hosts are solely responsible for complying with their individual tax obligations under Singapore law arising from the receipt of any Reward. If aspects of the Reward change outside the control of Young Living, or if, for any reason, all or any portion of the Reward is or becomes unavailable, Young Living will not be liable or responsible for any such changes. No transfer of the Reward to a third party is permitted. No cash substitutions will be offered. By accepting the Reward, the recipient agrees that Young Living shall not be liable for any injuries, damages, or losses of any kind resulting from or in connection with the awarding, acceptance, possession, or use of the Reward or any aspects or parts thereof.

Young Living will be the final arbiter of all rule interpretations and qualification determinations, and such decisions will be final. If applicable, Reward recipients will be responsible for paying all taxes on any subsidy or subsidies granted by Young Living. The Programme is void where prohibited by law. All Hosts who participate and qualify will be subject to audit.

By participating in the Programme, you (i) acknowledge compliance with these rules, including all eligibility requirements; (ii) warrant that any information you provide in connection with the Programme is true and accurate; and (iii) agree to be bound by the decisions of Young Living, which shall be final and binding in all matters relating to the Programme. Hosts who do not comply with these Programme rules, their Young Living Brand Partner Agreement, and Young Living's Policies and Procedures are subject to disqualification.

Young Living reserves the right, acting reasonably and in compliance with applicable law, to cancel, modify, or suspend the Programme where necessary due to operational, regulatory, or business reasons. Where practicable, reasonable notice will be provided.

The Programme is subject to all applicable laws and regulations of Singapore. All issues and questions concerning the construction, validity, interpretation, and enforceability of these Programme rules or the rights and obligations of Hosts and Young Living in connection with the Programme shall be governed by and construed in accordance with the substantive laws of Singapore, without regard to conflicts of law principles. All Hosts consent to the jurisdiction and venue of the courts of Singapore.

In the event of any conflict with any Programme Promotion details contained in these Programme Rules and Program details contained in other materials (including, without limitation, any point of sale, online, or print advertising), the details of the Programme as set forth in these Programme Rules shall prevail.

The invalidity or unenforceability of any provision of these Programme Rules shall not affect the validity or enforceability of any other provision. In the event that any provision is determined to be invalid or otherwise unenforceable or illegal, these Programme Rules shall otherwise remain in effect and be construed in accordance with their terms as if the invalid or illegal provision were not contained herein.
