DIRECTIONS

Apply mascara from the roots of the lashes to the tips on upper and lower lashes. Use tip of brush for hard-to-reach areas. For best results, allow mascara to dry between additional applications to build extra length.

Layer mascara to get an even more dramatic look. Apply Lengthening Mascara first to lift your lashes then layer Volumizing on top.
