

## Young Living Pinterest Clean-Up Sweepstakes

### OFFICIAL RULES

#### NO PURCHASE OR PAYMENT NECESSARY TO ENTER OR WIN.

1. **SWEEPSTAKES DESCRIPTION:** Young Living's Pinterest Clean-Up Sweepstakes (the "Sweepstakes") is offered by Young Living Essential Oils LC. The Sweepstakes starts May 1, 2016, at 12:01 AM Mountain Time and ends June 18, 2016, at 11:59 PM Mountain Time (the "Sweepstakes Period"). Beginning on Monday, May 8, 2016 and continuing each Monday until Monday, June 19, 2016, a drawing (the "Drawing") for the Prize will be conducted and a potential winner will be selected. All entries for the Drawing, must be received by 11:59 PM Mountain Time on the day prior to the Drawing. Young Living's method of timekeeping is the official time clock for the Sweepstakes and is final and undisputable.

2. **ELIGIBILITY:** To be eligible to enter, you must be a legal resident of the fifty United States or the District of Columbia and be at least eighteen (18) years of age at the time of entry. **VOID WHERE PROHIBITED BY LAW.** The following individuals are NOT eligible to enter or win Prizes: any person who is an employee, officer or director and any immediate family member of Young Living.

3. **HOW TO ENTER:** You may enter the Sweepstakes by visiting ensuring that your personal Pinterest page does not include any inaccurate information about Sponsor or its products that is not approved by the Sponsor. Then by posting one of the Pinterest pins provided at [www.youngliving.com/en\\_US/opportunity/promotions/pin-it-to-win-it](http://www.youngliving.com/en_US/opportunity/promotions/pin-it-to-win-it) on your cleaned-up Pinterest page you will automatically be entered into the Sweepstakes. **LIMIT ONE (1) ENTRY PER PERSON.**

Any attempt to obtain more than the stated number of entries by using multiple/different email addresses, identities, registrations and logins, or any other methods will void such entries and that entrant may be disqualified. Normal time, toll, connection and usage rates, if any, charged by your Internet service provider will apply. **AN ENTRY MUST BE RECEIVED DURING THE SWEEPSTAKES PERIOD TO BE ELIGIBLE.** No other means of transmission or delivery will be accepted. Late, incomplete or misdirected entries will be declared void and will be ineligible to win.

5. **DRAWING:** Beginning on Monday, May 8, 2016 and continuing each Monday until Monday, June 19, 2016, Young Living will conduct the Drawing and randomly draw one (1) entry from among all eligible entries received. The odds of winning depend on the total number of eligible entries received. The selected entrant will, subject to verification of eligibility and compliance with these Official Rules, be eligible to win the Prize.

6. **AWARDING OF PRIZE:** The potential winner will be contacted by phone, mail, or email with instructions on how to claim his/her Prize. The potential winner must follow such instructions and submit his or her required information within three (3) days of notification. For purposes of these Official Rules, after submitting his/her required information, the potential winner shall become the winner (the "Winner"). If a potential winner is found to be ineligible or not in compliance with these Official Rules or declines to accept the Prize, or if Young Living is unable to contact such person within a reasonable period, or in the event that the Prize notification or Prize is returned undeliverable, the Prize will be forfeited and, at Young Living's sole discretion, the Prize may be awarded to an alternate entrant selected at random. The potential winner may be required to furnish proof of identification to determine eligibility. Before being declared an official Winner, the potential winner may be required to execute and return a Declaration or Affidavit of Eligibility/Liability & Publicity Release and a W9 form no later than ten (10) business days after the time such forms are postmarked as having been sent by Young Living or the potential winner will forfeit his/her Prize.

The Prize will be shipped to the Winner's home addresses within thirty (30) days after the close of the Sweepstakes Period. Prize may not be transferred or redeemed for cash (except to the extent required by applicable law) and must be accepted as awarded, with no substitutions of any kind, except substitutions made by Young Living, who reserves the right, in its sole discretion, to substitute the Prize (or portion thereof) with one of comparable or greater value. All federal, provincial, state, and local taxes (including income, duty and withholding taxes), if any, as well as any other costs and expenses associated with Prize acceptance and use are the Winner's responsibility.
