

## **YL GO AND YL GO+ TERMS AND CONDITIONS**

The following constitutes the terms and conditions (“**Terms**”) for YL GO and YL GO+ (sometimes referred to collectively as the “**Shipping Services**”). These Terms are between you and Young Living Essential Oils, LC and/or its affiliates (“**Young Living**”) and they govern Young Living’s respective rights and obligations along with your respective rights and obligations, as those rights and obligations relate to the Shipping Services.

Your membership of YL GO and/or YL GO+ is also governed by the Young Living Policies and Procedures and all other agreements incorporated therein, which (as changed over time) are incorporated into these Terms. In the event of any inconsistency, these Terms shall prevail. By signing up for YL GO and/or YL GO+, you agree to all such terms, conditions, requirements, and limitations.

### **BENEFITS OF THE SHIPPING SERVICES TO MEMBERS**

Enrolling in either of the Shipping Services will provide you with (1) a 2-4 day delivery period and (2) prioritized processing so that your shipments are prioritized above all other shipments, except those shipments which are being overnighted. Additionally, if you are a member of the Shipping Services, you may upgrade your processing to overnight shipping for a discounted rate, though such an upgrade will be reduced from your remaining qualifying free shipments. Still, all benefits relating to the Shipping Services are subject to the limitations and restrictions as provided herein.

### **YL GO SHIPPING AND QUALIFYING ORDERS**

YL GO is a 12 month shipping subscription and provides you with free shipping for up to 12 qualifying Essential Rewards Program (“**ER**”) orders (1 per month) and, in the first year, 1 additional qualifying ER shipment (13 months total). Still, the YL GO benefits provided to you are subject to potential issues with inventory, order deadlines, and shipping addresses. As stated earlier, the YL GO benefits are limited to (1) a certain number of shipments and (2) certain products sold by Young Living. Accordingly, you will pay applicable shipping charges for all products which do not qualify for YL GO shipping. Additionally, even if all products ordered qualify for YL GO shipping, your order may still be subject to product, order, handling fees, and/or taxes.

### **YL GO+ SHIPPING AND QUALIFYING ORDERS**

YL GO+ is a 12 month shipping subscription and provides you with free shipping for up to 12 qualifying ER orders (1 per month) and 24 additional qualifying shipments. Additionally, every qualifying order AFTER your 36<sup>th</sup> order during the 12 month subscription period will ship at discounted rates, subject to the shipping method selected. Still, the YL GO+ benefits provided to you are subject to potential issues with inventory, order deadlines, and shipping addresses. As stated earlier, the YL GO+ benefits are limited to (1) a certain number of shipments and (2) certain products sold by Young Living. Accordingly, you will pay applicable shipping charges for all products which do not qualify for YL GO shipping. Additionally, even if all products ordered

qualify for YL GO shipping, your order may still be subject to product, order, handling fees, taxes, and other related costs.

### **UPGRADING TO YL GO+**

If you are enrolled in the YL GO shipping service, you may upgrade to YL GO+ at any point during your 12 month subscription period, and if any of the YL GO 12 qualifying ER shipments are unused at the time of the upgrade, then, in the sole discretion of Young Living, the value of such shipments, as determined by Young Living, may be credited towards your YL GO+ enrollment fee.

### **OTHER TERMS RELATED TO THE SHIPPING SERVICES**

Young Living, in its sole discretion and for any reason, reserves the right to exclude any product from any shipment, including shipments qualifying under the Shipping Services.

Young Living, in its sole discretion and for any reason, may add, remove, and otherwise change any membership benefit for either or both of the Shipping Services.

No rights or benefits related to either of the Shipping Services are assignable or transferable by you.

Young Living, in its sole discretion and for any reason, may accept or deny membership for either of the Shipping Services.

Members located in the Northern Mariana Islands, American Samoa, Puerto Rico, and Guam may sign up for the Shipping Services. However, only shipments delivered to the 50 United States are eligible to benefit from the Shipping Services.

Regardless of any settings or preferences for any account related to the Shipping Services, Young Living reserves the right to send you, and you consent to receive, email and other communications related your account and/or the Shipping Services. You agree that all agreements, notices, disclosures, and other communications that are electronically provided by Young Living satisfy any legal requirement that such communication be made in writing.

### **EXPORT POLICY**

You acknowledge and agree that you must comply with all U.S. and other custom, export, or re-export restrictions and any other applicable law relating to the goods purchased.

### **RISK OF LOSS**

Title and risk of loss for all orders made using the Shipping Services will pass to you upon Young Living's delivery of the order and its related products to the carrier.

### **MEMBERSHIP CANCELATION**

You may cancel YL GO or YL GO+ membership account at any time. Young Living will refund your membership fee in full if you cancel the membership within 20 days of signing up; provided, however, Young Living will withhold from your refund (or may charge you) the value of the Shipping Services benefits you used during the 20 day period. If you cancel at any other time, Young Living will not refund any portion of the membership fee, but you will still have access to your remaining unused YL GO or YL GO+ qualifying free shipments.

#### **AUTOMATIC MEMBERSHIP RENEWAL**

YOUR MEMBERSHIP TO THE SHIPPING SERVICES WILL BE AUTOMATICALLY RENEWED AT THE END OF THE 12 MONTH PERIOD, UNLESS YOU NOTIFY YOUNG LIVING BEFORE YOU ARE CHARGED THAT YOU WILL CANCEL YOUR MEMBERSHIP. YOUNG LIVING WILL PROVIDE YOU 1 MONTH NOTICE PRIOR TO YOUR MEMBERSHIP BEING RENEWED. YOUNG LIVING, IN ITS SOLE DISCRETION, RESERVES THE RIGHT TO CHANGE THESE TERMS AT ANY TIME SO THAT NO NOTICE MAY BE PROVIDED TO YOU BEFORE YOUR MEMBERSHIP IS RENEWED.

#### **YOUNG LIVING’S RIGHT TO TERMINATE**

Young Living, in its sole discretion and for any reason, reserves the right to terminate your membership to either of the Shipping Services without notice. If Young Living does terminate your membership prior to the conclusion of the 12 month subscription period, Young Living will provide you a prorated refund calculated by the number of full months still remaining in your subscription period. Still, Young Living reserves the right to withhold any refund for early termination if Young Living, in its sole discretion, determines that you have engaged in conduct that violates these Terms or any applicable law, involves fraud or misuse of any Shipping Services membership, or involves fraud or misuse of your Shipping Services membership, or is otherwise harmful in any way to Young Living or to another member of the Shipping Services.

#### **AMENDMENTS TO THESE TERMS**

Young Living, in its sole discretion and for any reason, may change and amend these Terms or any feature, characteristic, and/or aspect of your membership to either of the Shipping Services, without providing you notice. YOUR CONTINUED MEMBERSHIP OF THE SHIPPING SERVICES WILL CONSTITUTE ACCEPTANCE OF ANY CHANGES TO THESE TERMS OR THE SHIPPING SERVICES.

## **LIMITATION OF LIABILITY**

IN ADDITION TO OTHER LIMITATIONS FOUND IN THE YOUNG LIVING POLICIES AND PROCEDURES, UNDER NO CIRCUMSTANCES AND UNDER NO LEGAL OR EQUITABLE THEORY, WHETHER IN TORT, CONTRACT, STRICT LIABILITY OR OTHERWISE, SHALL YOUNG LIVING OR ANY OF ITS AFFILIATES, EMPLOYEES, DIRECTORS, OFFICERS, AGENTS, VENDORS OR SUPPLIERS BE LIABLE TO YOU OR ANY OTHER PERSON FOR ANY INDIRECT, SPECIAL, INCIDENTAL OR CONSEQUENTIAL LOSSES OR DAMAGES OF ANY NATURE ARISING OUT OF OR IN CONNECTION WITH THE USE OF OR INABILITY TO USE YOUR SHIPPING SERVICES MEMBERSHIP. SUBJECT TO THE FOREGOING, IN NO EVENT WILL YOUNG LIVING BE LIABLE TO YOU FOR ANY DAMAGES IN EXCESS OF THE FEES PAID BY YOU IN CONNECTION WITH YOUR MEMBERSHIP IN THE SHIPPING SERVICES DURING THE SIX MONTH PERIOD PRECEDING THE DATE ON WHICH THE CLAIM AROSE.

## **SEVERABILITY**

Every provision of these Terms is intended to be severable. If any aspect of these Terms, or any change to any aspect of these Terms, is illegal or invalid for any reason whatsoever, such illegality or invalidity shall not affect the validity of the remainder of the Terms or any changes to these Terms that are otherwise legal and valid.

## **MANDATORY ARBITRATION**

ANY DISPUTE OR CLAIM RELATING IN ANY WAY TO THESE TERMS OR YOUR MEMBERSHIP IN THE SHIPPING SERVICES, SHALL BE RESOLVED BY BINDING ARBITRATION, RATHER THAN IN COURT, AND THEREFORE ALL SUCH DISPUTES WILL BE SUBJECT TO THE FEDERAL ARBITRATION ACT.

## **GOVERNING LAW**

By using the Shipping Services you hereby agree that that the Federal Arbitration Act and the laws of the state of Utah, without regard to principles of conflict laws, will govern these Terms and any dispute or claim arising out of or relating to the Shipping Services.
