

MVP in SLC Promotion Official Rules

No purchase necessary to enter or win

Promotion Description

The MVP in SLC Promotion (the "Promotion") is sponsored by Young Living Essential Oils, LC, located at 3125 Executive Parkway, Lehi, UT 84043. The Promotion begins March 1, 2017, at 12 a.m., MT, and ends at 11:59 p.m., MT, on March 31, 2017 (the "Promotion Period"). Young Living's method of timekeeping is the official time clock for the Promotion and is final and undisputable. Eligible participants will participate in a random drawing for prizes related to the 2017 Young Living International Grand Convention (the "Convention") to be held in Salt Lake City, UT, USA between June 25, 2017 and July 1, 2017.

Eligibility

The Promotion is open only to active Young Living members, not including professional account members or retail customers, who are legal residents of the U.S. and who are 18 years of age or older as of March 1, 2017 (herein "Members"). This Promotion shall exclude all Members in NFR markets. Void where prohibited. Active members are Young Living members who have made a purchase of at least 50 PV in the last 12 months and signed the Young Living Member Agreement.

How to Enter and Win

To enter without a purchase, Members must send a postcard or a 3x5 card that includes their name, member number, mailing address, day and evening telephone numbers, their email address (if they have one), and the name "MVP in SLC Promotion." This must be mailed to: MVP in SLC Promotion, Young Living Essential Oils, Attn. Promotions Team, Thanksgiving Point Business Park, 3125 Executive Parkway, Lehi, UT 84043. Entries must be postmarked and received before March 31, 2017. Entries that do not comply with these specifications will not be considered. Members may enter as often as they wish, but each entry must be mailed separately.

To enter with a purchase, Members either (i) make a product purchase having a combined total PV value of at least 50 PV in an Essential Rewards order during the Promotion Period or (ii) make a Quick Order having a combined total PV value of at least 100 PV. Multiple such Quick Order entries are permitted. Each such order placed during the Promotion Period will qualify as a separate entry made the date the order is placed.

No preference will be given based on the method of entry.

Winners will be selected at random from all qualifying entries received during the applicable drawing period. Five separate sets of drawings will be conducted as follows:

- Drawing 1 will be held on March 7. Winners of Drawing 1 will be randomly selected from all qualifying entries received on March 1-4 and postcard entries received on March 5-6. Winners of Drawing 1 will be notified on March 9.
- Drawing 2 will be held on March 14. Winners of Drawing 2 will be randomly selected from all qualifying purchase entries received on March 5-11 and all qualifying postcard entries received on March 7-13. Winners of Drawing 2 will be notified on March 16.
- Drawing 3 will be held on March 21. Winners of Drawing 3 will be randomly selected from all qualifying purchase entries received on March 12-18 and all qualifying postcard entries received on March 14-20. Winners of Drawing 3 will be notified on March 23.

- Drawing 4 will be held on March 28. Winners of Drawing 4 will be randomly selected from all qualifying purchase entries received on March 19-25 and all qualifying postcard entries received on March 21-27. Winners of Drawing 4 will be notified on March 30.
- Drawing 5 will be held on April 4. Winners of Drawing 5 will be randomly selected from all qualifying purchase entries received on March 26-31 and all qualifying postcard entries received on March 28-31. Winners of Drawing 5 will be notified on April 6.

Each drawing (Drawings 1-5) will select 158 winners for the following 158 prizes. Each Member may only receive one prize per week.

- 50 – Thieves Prizes (see the Prize sections for prize details)
- 5 – Inspiration Prizes (see the Prize sections for prize details)

Prizes

The following prizes will be awarded during each drawing:

- **Thieves Prize:** A discount code for two free tickets to the Convention. The registration code covers two registrations, so if you and your guest are already signed up for the Convention, you may share the code with up to two friends and receive a \$25 rebate on your own Convention registration for each time the code is used. (ARV \$458 USD)
- **Inspiration Prize:** Two VIP seats to the convention’s general sessions and the closing concert.
- **Shine Like a Diamond Prize:** One Convention jersey, a discount code for two free Convention registrations, VIP seating at the general sessions and the closing concert for two, and VIP check-in at the Convention for two. The registration code covers two registrations, so if you and your guest are already signed up for the Convention, you may share the code with up to two friends and receive a \$25 rebate on your own Convention registration for each time the code is used. (ARV \$700 USD)
- **The Royal Treatment Prize:** One Convention jersey, a discount code for two free Convention registrations, two non-transferrable YL Spa appointments, VIP seating at the general sessions and the closing concert, and VIP check-in at Convention. The registration code covers two registrations, so if you and your guest are already signed up for the Convention, share the code with up to two friends and receive a \$25 rebate on your own Convention registration for each time the code is used. (ARV \$1000 USD)

The odds of winning depend on the number of entries received during the applicable drawing period.

The physical portions of the prizes will awarded at Convention. Winners must be present at Convention to receive their prize.

Notification/Prize Acceptance

A confirmation will be mailed to the Prize winner, as detailed above. Winner must accept the prize by April 28, 2017. Details on how to do so will be provided to the winner. Prize information will be delivered to the Prize winner by Young Living.
