PHARMACOLOGICAL ACTION

completely abolishes the expected immune factor responses to endotoxin and diminishes the production of pro-inflammatory cytokines in vivo. It has been found that lauric acid is an effective compound in VCO. Lauric acid is the precursor of monolaurin (Pereira et al., 2004), which has been shown to modulate immune cell proliferation (Witcher et al., 1996) and possess antimicrobial activity (Bergsson et al., 2002). These components have been shown to modulate many of the aforementioned effects as well as some immune responses. Oregano oil is high in phenols, which are natural phytochemical compounds with beneficial antioxidant effects. Thymus vulgaris essential oil (TEO) is a mixture of monoterpenes. The main compounds of this oil are the natural terpenoid thymol and its phenol isomer carvacrol (CVL), which have antioxidative, antimicrobial, antitussive, expectorant, antispasmodic. and antibacterial effects.
