A registration fee of \$15.00 AUD / \$16.50 NZD per person is mandatory. This amount is payable by 6pm (Sydney time) on 1st October, 2018. The first 75 members who achieve the qualification criteria will be awarded a spot. There can only be 75 qualifiers. 5 additional registered members will be chosen as Wild Cards to attend without the need to qualify or pay to attend event workshops (registration fee must be paid).

Stars and Senior Stars rank up to Executive 星级和高级星级会员晋升至总监级会员

*Any member who ranked Star or Senior Star in June 2018 and any member who has achieved the rank of Executive **once only** in the last two years (between 1st July 2016 and 31st July 2018) would be eligible to take part in the 'Stars and Senior Stars rank up to Executive' competition.*

适用于在 2018 年 6 月晋升至星级或高级星级的会员以及在过去两年（2016 年 7 月 1 日至 2018 年 7 月 31 日之间）曾有一次晋升至总监级别的会员。

1. Personally enrol 4 new members with an Australian or New Zealand address on Essential Rewards at 100 PV or more between 1 August - 30 November, 2018.

2. Qualify as a New Executive at least 2 of the 4 months within the 1 August - 30 November, 2018 qualification period.

3. Executive months do not need to be consecutive.保持总监级别的月份不需要连续。

4. Member may not drop below the rank of Senior Star during the non-qualifying month.在非符合资格的月份，会员的位阶不可以降至高级星级以下。

Executives rank up to Silver 总监级会员晋升至银级会员

Any member who ranked Executive in June 2018 and any member who has achieved the rank of Silver once or twice in the last two years (between 1st July 2016 and 31st July 2018) would be eligible to take part in the 'Executives rank up to Silver' competition.

Personally enrol 6 new members with an Australian or New Zealand address on Essential Rewards at 100 PV or more between 1 August - 30 November, 2018.

1. Qualify at Silver for 2 of the 4 months within the 1 August - 30 November, 2018 period (additional rewards apply for New Silver members who qualify over all 4 months).

位阶晋升为银级并且在2018年8月1日至11月30日4个月之间保持至少2个月为银级级别（新的银级会员在活动期间4个月内都保持银级级别将会赢得额外奖励）。

2. Qualification months do not need to be consecutive. However, to be recognised as a New Silver, you must have 3 consecutive months.

3. Members may not drop below the rank of Executive during the non-qualifying months. 在非符合资格的月份，会员的位阶不可以降至总监级别以下。

After ranking up, members cannot fall below one rank. For example, an Executive ranking up to Silver cannot rank Senior Star in a non-qualifying month.
